### PRESIDENT'S CHALLENGE!

It can be anything you want - table topper, wall hanging, mug rug, placemat, project bag, zipper bag. All items finished before the quilt show can be proudly displayed at the show. Have some fun!

**Folded star class after this meeting:** Alexander Moriarity will teach the folded star (woven star/Moravian star/German star) ornament after this month's meeting. Supplies suggested by Alexander: 1 package of 1" bias binding, Best Press or starch, scissors, iron/mini iron, awl, 8" piece of twine/ribbon, hemostat/tweezers/bodkin and a large needle for the twine/ribbon.



Dixie isn't sure if we have Christmas fabric upstairs in the storage area. Rather than making the star out of only one color of bias tape, it might be fun to share colors from the tape others bring. Or? Bring some Christmas/holiday fabric for your stars. If each of us brings one fabric, we could cut/share strips of fabrics with others.

**Quilt Show 2024:** The committee welcomes everyone to attend our meetings. The next meeting is scheduled for Wednesday, December 6, at 5:00 at Raydene's house, 4453 Eyelet Court.

Award ribbons are finished! We owe a big thank you to Debbie Germain, Geri Fudge and Dixie Alms for all their work and effort!

We have a vendor! Todd Wicks (aka Caribou Quilts) is bringing his barn quilts to town. Some of you will remember him from his years of teaching in Juneau's schools.

We will soon be pursuing sponsorships (\$200) and welcome your suggestions and assistance of businesses to approach. Individuals and members are also welcome to purchase sponsorships.

Since we are now six months out from the show, we would like to start planning for the numbers of quilts that you plan to enter whether you plan to have them judged or not. Watch for a survey coming out soon.

**Nancy Fuka zoom presentation:** Since we were not allowed to record Nancy's zoom presentation, Dixie did not take formal notes until we reached the question/answer part of the gathering. Here are her notes:

Nancy has been quilting for 40 years but has sewn since she was a child. She currently teaches across the country and is the only certified judge in New Mexico.

MODERN QUILTS: Just because a quilt is made today does not make it "modern". It is the aesthetic of the quilt that matters. A modern quilt has no sashing or borders. The design on the quilt goes to the edge of the quilt and is bound. There is no traditional piecing such as a fan block. A modern quilt may start with a traditional blocks such as a fan, but the design of the block has been modified/modernized by using color, size or settings that would not be considered traditional. Modern quilting typically shows a lot of match-stick quilting and pebbles. Civil war fabrics are not modern and are not found in modern quilts.

Nancy added that WE define our categories. She will have a copy of our categories and will judge our quilts as defined by our categories.

It was asked where specialty quilts belong, such as wool applique. Nancy said she sees them going into the applique category for sure or in a hand work category. She added that some shows have a category for embellished quilts. She suggested that whatever a quilt has the most of is its category. If a quilt has 50% or more applique, it would go into the applique category. If a quilt is 50% or more pieced, it would make sense for it to go into a pieced category.

# October 21, 2023 DRAFT MINUTES

**ABSENT:** Marcie Benvin, Vice President.

**President** Ann called the meeting to order at 10:37 am. Based on the number of people who have paid dues as of today, we have met our quorum of 12 members.

**Visitors:** Sarah McNair-Grove introduced herself and joined after the meeting.

**Minutes:** Genelle Massey moved we approve the minutes to the September meeting. Judy Macnak seconded. No opposition. (*Heather Ramseth arrived.*)

**Audit committee:** Laurie Adamson reported on the findings of the committee. They were unable to complete their task on October 4<sup>th</sup> as they did not have all the necessary items. They met again on October 11<sup>th</sup> with Debbie Germain answering questions and audited the materials

they were presented. They have asked for additional information before the audit can be fully completed. Their written report dated October 21, 2023 was submitted.

**Education Report:** Ann gave Marcie the file with the four proposals. Marcie will start with the first of the proposals and see if we can arrange the instructor for next spring.

**Comfort Quilts:** Judy Morley reported that she hasn't finished quilting anything recently. We sent nine quilts to Maui, and Judy bound the nine quilts she had and gave them to the Cancer Connection. She has 12 that need to be quilted. Ann brought the kits down from upstairs and invited anyone to take a kit to complete. She also brought down the pillowcase kits. Her goal is to empty the storage area upstairs.

**Treasurer's report:** Debbie prepared two reports for today: one for the second half of September and one from mid-September through October 20<sup>th</sup>. The full October report will be presented at the November membership meeting. The report for the last half of September is as follows:

Discussion ensued regarding how much detail members want on how Guild funds are spent. Karen Paulick said she would like to see the details in the newsletter making a detailed report at the meeting unnecessary. Geri would like to see the report in writing. Laurie asked if members approve the treasurer's report. Debbie said we do not, but she would like to know what members want to see. Bev wanted to know what will be presented in the newsletter. Debbie said the audit committee suggested the monthly treasurer's report follow the full month like the bank statement. It was clear that members want to see details in the newsletter. The report in the minutes will be a brief report.

Debbie has found a bookkeeping program that was built by two women working for non-profit organizations that provides the information we need. The cost is \$179/year. (Deborah Johnson left.) Debbie is using the program free until November 4<sup>th</sup>. She added that the \$179 fee has been added into the proposed budget. She is hoping to offset the cost with other reductions in the budget. Debbie looked at our last budget and removed items that have no cost for this year. She added that we can save \$36/year by renewing our website for two years rather than paying annually. She pointed out that we have been paying \$130/year for computer maintenance services which has only been used twice that she could find in the past five years. Debbie has removed that fee from the budget and would like to cancel the maintenance contract. Square fees last year were more than \$10. Since we are planning more activities this year, she has increased that line item to \$50. Debbie asked what Miscellaneous Promotions are? They are anything we purchase for drawings and such. Karen Paulick was asked if all our newsletters are up on the website. She said she puts them up as soon as she receives them. Judy Morley said she would be better at turning in her receipts for Comfort Quilt expenses. (Karen Smith left to go to work and left a written proxy for Karen Paulick to vote for her.) Heather moved and Karen Paulick seconded a motion to approve the 2023-24 proposed budget. Motion was approved unanimously.

Quilt Show Committee Report: (Clare Brooks on Zoom.) Laurie reported that Nancy Fuka's zoom presentation was interesting and informative. The committee will soon talk to businesses and others about sponsorships (\$200). If you know of a business, or if you are interested in purchasing a sponsorship, please let us know. We will be needing items for the auction and for the sale. We are still handing out ornament kits and would appreciate if you made more in addition to the one you made for yourself. Sale items can be turned in at any time. We will be needing a lot of volunteers at the show and will be seeking members to demonstrate various techniques of all kinds. If you would like to demonstrate something special that you do, please let us know. Laurie added that a quilt in the show can also be an auction item.

Christmas Party: Christine reported that our Christmas Party will be held December 2 from 2-4:30 at the Safe Harbor Church on Ka-See-An Drive which is off Lee Smith Drive. Their parking lot is huge, and they have signs to help find the church. Christine has asked how we can best serve the church and will send out flyers before the party. Watch your emails! Alexander asked if we will have a cookie exchange. Christine said nothing formal is planned unless someone wants to organize it. We will have a potluck, games and our Secret Christmas Swap for those who signed up.

(Those on Zoom didn't hear anything after Laurie's Quilt Show report. Ann summarized what has been said for them.)

**Quilt Show Judge Zoom:** Nancy Fuka gave an informative presentation Thursday evening that was attended by only six members. Her contract stipulated it not be recorded. Ann shared information, and Laurie mentioned that Nancy talked a lot about bindings and said it makes no difference if the guilt is bound by hand or machine.

**Annual Survey:** Ann has sent out the survey. If you have not responded, please do as soon as you can.

#### **UNFINISHED BUSINESS:**

**Dues:** Dues must be paid by November 30<sup>th</sup> to be included in this year's directory and to enter anything into the Quilt Show next May. Due to Square fees, we request you pay an additional \$1.50 if you choose to pay by debit or credit card.

**UFO contracts:** Current UFO contracts end at our March 24<sup>th</sup> meeting so items may be included in the Quilt Show. A new UFO contract year will begin in January 2024 and will end at our August meeting to coincide with our membership year.

**Christmas Swap:** Today is the last call for anyone to sign up for the gift exchange. Forms are here at the front table. Any forms given to Ann today will be given to JoAnn Steininger. All of the items on the gift list can be made in a short time.

**Sampler Platter:** Karen Paulick, Judy Macnak and Judy Morley attended and said they enjoyed the sessions they watched. All sessions can be reviewed 48 hours later if we are unable to watch the sessions live. Alexander also watched and said the sessions were amazing. He has the handout from the label presentation that taught how to put a label on prior to quilting. He recommended that we continue participating in available Sampler Platter presentations.

**Geri's rope bowl class:** Sign in sheet is on the front table so we can track how many members attend sessions taught by members. Geri is teaching today after the meeting.

### **NEW BUSINESS:**

**Second Saturday Market:** The Mendenhall Mall provides Second Saturday Market for members of the public to offer their wares for sale. Ann has signed CCQ up to host a sale table on November 11<sup>th</sup>. She has the seven totes from our last Quilt Show, pillowcases from Debbie and other items that would make good Christmas gifts. We have a banner to display and could also have flyers and membership applications available.

Quilt Labels: We have talked in the past about making generic labels for the Comfort Quilts. A generic label would state: May this quilt give you comfort. Donated by CCQ in 2023. It is suggested that if quilters want their names on the label, they would be responsible for making the label. Karen Paulick said she liked the idea of a generic label as it would make it easier to get the quilt finished quickly. Debbie asked how Judy Morley felt about a generic label since she is doing the quilting. Judy feels it is important to have names on them. Christine added that one of her patients received one of our quilts and sent a thank you referencing the name on the quilt. Sandra remembers that names were added to the labels as a record that would help us keep track of members making the guilts. Bev noted that she is a member of a group that is making over 50 quilts for the Shrine. She said their quilt labels include a message and the name of the group with the date. They don't put their names on the quilts. Genelle said it warmed her heart to see the names of people who have passed on the quilts displayed at the dialysis center. Nancy suggested we could make several generic labels. She added that if a quilter wanted his/her name on the quilt, s/he could make the label and also credit the quilter. Heather agreed. A generic label would speed the finishing process. If you make your own label which includes the name of the Guild and the date, pin it to the quilt top when giving it to Judy. Debbie will make a bunch of generic labels that will go on quilts that Judy receives without a label pinned to them. Geri asked if the quilter's name will be on the generic label that has no

piecer's name. No, because members of the public would assume that the quilter did all the work on the quilt. Judy said a label could just as easily say: *Pieced by \_\_\_\_\_ (a CCQ member)*. Nancy thinks Judy's quilting needs to be acknowledged. Ann was asked if she is doing any of the Guild quilting; she is not as she does not have the time.

**Quilt retreat:** We have rented the Jubilee Cabin at the Shrine from February 8-12 for a retreat. We need at least 10 people to sign up. Costs will be split among those signing up with the organizer/coordinator's fee paid by the Guild. It was asked if people could come out and sew during the day. No, it's like daycare or a gym membership where you pay the fee whether you are there for the entire time or not. Bev said she was snow bound out there one year. Debbie said she has gone out there at that time of year for several years on retreats and has never had trouble. The Shrine is pretty good at keeping the roads cleared.

**Warming Shelter:** Alexander commented that this winter's Warming Shelter will be in Thane. He asked if we might be able to donate quilts. The last time we asked, they wanted blankets rather than quilts.

### **OTHER BUSINESS:**

**Treasurer's position:** It is very likely that Debbie will soon be moving to Wasilla until late May. She is very willing to remain as treasurer and can work electronically as she currently does for four other businesses. If we would like someone else to do the job, she is willing to give it up. Dixie added that she and Debbie plan to start working on Quilt Show ribbons next week due to Debbie's plans. Ann stated she has no problem with Debbie being a long-distance treasurer. Others also voiced approval with Debbie remaining as treasurer.

**Freebies:** Judy Nyman will be moving soon and has provided free materials on the back table. Judy Macnak has also provided items free for the taking.

**SHOW & TELL** (I noticed both Mindy and Sandra on zoom but don't know when you joined the meeting.)

The meeting adjourned at 11:55 am.


